Approval of Agenda

Reports

Coronavirus

The fact that the Park has so far remained virtually free of Covid cases is likely a direct result of residents and visitors adhering to local and state health care directives, mainly wearing masks – correctly – and maintaining social distance, even when outdoors. As most Marin Valley residents are in a vulnerable age group, we all need to be even more cautious than ever, despite the fact that we may be experiencing “pandemic fatigue.”

Though some residents have received at least one vaccination dose, vaccinations for many residents may still be weeks away. Even after both doses of the vaccine are received, mask-wearing and social distancing will still be necessary for quite some time. It is recommended that residents get vaccinated as soon as possible, through whatever channel first becomes

available to that individual, especially since new variants of the virus are quickly becoming more widespread.

#### Park Security

Kevin continues to monitor the area in and around the Park, and reported that there are no occupied campsites at present.

A discussion was held about the continuing problem of residents trespassing on St. Vincent's property, both from the southern easement and on the ridgetop trail, as well as the trespassing onto Marin Valley property by horseback riders coming from St. Vincent's. Carol-Joy will have followed up with Matt Greenberg, who has ordered the placement of a double-sided no-trespassing sign on the easement that leads to St. Vincent's property. Carol-Joy was asked to urge Matt to have the sign placed as close as possible to St. Vincent's, which she will do.

John F. is continuing to pursue the formation of a Neighborhood Watch type group in the Park. John has spoken with two Novato Police officers from what is called the Novato Response Team. They would like to hold a community meeting. John will follow up and try to schedule a Zoom meeting for April.

#### Marin Valley Firewise

John H. reported that there will be a FIRESafe MARIN Board meeting on Friday, March 12 at 9:00 a.m., followed by a Firewise Community leaders meeting at 11:00. For the Zoom links to either or both, contact John H.

John H. reminded the committee that there will be a FIRESafeMARIN webinar on Tuesday, March 30 at 6:00 p.m. Called "Defensible Space," the Zoom link is <https://firesafemarin.zoom.us/j/87382415962>. The speaker will be Todd Lando, Wildfire Hazard Mitigation Specialist/Battalion Chief, Central Marin Fire Department. If the Zoom call is at capacity, it can be viewed in real time on Facebook. It will be available for viewing after the

event on the FIREsafe MARIN website and also on our website, [www.marinvalley.net](http://www.marinvalley.net).

Bill and John H. are working with the Novato Fire District on plans for evaluations by a Novato Fire District Wildfire Mitigation Specialist for the entire Park, including individual homesites. MVEST will use this as an educational opportunity for residents, stressing that it is entirely free and voluntary for the resident and that the information about the resident's property will be private, shared only with that resident. Bill has written an article about the program for the April *Echo*.

John H. reported that the Park's 2021 fuel break planning is under way and will probably again include goats' grazing as part of the process. Chipper day/s may also be included, and there is a possibility of procuring grant funds for parts of the overall process.

John H. reported on possible grants **for homeowners for fire risk-reducing yardwork (\$500), and** for home-hardening measures -- e.g., replacing single-pane windows with double-pane ones or changing home siding to a more fire-resistant material -- for matching funds, up to \$2,500, which would come from the Novato Fire District as part of the efforts of the Marin Wildfire Prevention Authority. MVEST may be able to help with the application process.

There is also the possibility of obtaining a similar matching-funds grant for improvements to the MVMCC clubhouse, up to \$1,500, from the same source. John H. will write an article about these grant programs for the May *Echo*.

John F. and John H. have developed an instructional video regarding resident utility connections, or pedestals. This will be the first in a series of video trainings for residents. They will be presented via Zoom meetings that will be recorded and later posted to the website, [www.marinvalley.net](http://www.marinvalley.net). This format will allow for a question-and-answer period and therefore may prove more useful than a straightforward training video. This first Zoom meeting will be held on Wednesday, March 24 at 6:30 p.m. The information was presented in printed form in the March *Echo*, for which John F. has received much positive feedback from residents.

The next topic to be handled in this fashion is home laundry dryer safety, which David Gray has researched. His article on it will appear in the April *Echo*, but the date for the Zoom presentation is yet to be determined.

David is also researching a dryer vent cleaner that can be used by the homeowner, and has also found that the going rate for commercial companies to clean dryer vent systems seems to be \$275.

The following topic in the MVEST Zoom meeting series will be the wildfire mitigation program mentioned above, which will also be promoted via tube flyers.

John H. brought up the subject of residents' probable need for masks this summer due to the expected bad air quality caused by wildfires. He suggested that MVEST buy a quantity of N95 masks and distribute them to residents, as was done in 2019. He will further research the availability and cost, especially since wildfire season may come early and viciously this year.

#### Yard Maintenance Program

Peggy Hill reported that at least four yards, possibly more, will be pruned and neatened over two days at the end of March, using funds from the newly created Humanitarian Fund for Yard Maintenance, under the auspices of PAC.
