Park Security

Kevin reported that many residents still do not seem to be aware of the procedure to follow when they see or know of a crime in the Park. Therefore, Erma will place the following wording, or something like it, in the *Echo*:

The motto, "If you see something, say something," applies to Marin Valley. That is, residents are reminded to call 9-1-1 to report all crimes in progress and to contact Matt Greenberg to report suspicious circumstances or individuals noted in the Park by calling 415-883-5911 any time day or night. Any cases of property theft should be reported to Matt with all relevant data such as time, date, and a description of the stolen property. This will help such investigation as reviewing camera footage of that day from the Park's cameras.

MVEST Trainings

There was a discussion about the meeting for Block Captains that took place on September 11. There were about 30 attendees, and at least one new Block Captain was recruited. All agreed the presentation and the refreshments were excellent.

In the future, Zone Chiefs will be provided with scripts with which to conduct their monthly radio drills with their respective Block Captains. In addition, people trained in Incident Command will be asked to participate in these to make them more like real-world situations.

It was decided that the MVEST Preparedness Fair, usually held annually, will be postponed until 2022.

It was decided that the evacuation preparedness drills will also be postponed until 2022 and that there will be several, each dealing with a different aspect, e.g., quickly grabbing your go bag and getting into your car to leave the Park.

There was no report on the MVEST Emergency Handbook for all.

The MVEST "Start Here" handbook for the Marin Valley Incident Command is being updated by John H.

Bill is completing the work on changing the lockbox for emergency clubhouse access.

Concerning the issue of home replacement cost projections for insurance purposes, John F., David, John H., and Erma are further researching this.

New Business

There was a discussion about what role, if any, MVEST might play in connection with Marin's Center for Independent Living.

There was a discussion about the possibility of expanding this committee or forming standing subcommittees within it.
