The first episode, which aired on September 16, is now streaming on demand at www.FireSafeMarin.org. Entitled "Ember Storms + When the Power Goes Out," it can also be watched via YouTube and in other ways. Erma suggested that Block Captains recommend it to residents because it contains such invaluable information.

He also reported that after canvassing the nurses in Marin Valley, he found that there is consensus among them that when someone appears to have heat stress, the most important thing to do is to call 9-1-1 immediately.

John F. will write an article for the November issue dealing with Red Flag warnings, that they should basically serve as evacuation warnings, i.e. GET YOUR GO BAG READY!

Bill will also develop a script to be used for robocalls when there are Red Flag Warning days.
