The *ad hoc* subcommittee regarding the possibility of expanding this committee or forming standing subcommittees within it, consisting of Bill, David, and John H., will meet soon.

New Business

MVEST Power Outage Protocol

A subcommittee – John F., John H., and Steve -- was formed to discuss the formation of an MVEST role and protocol concerning power outages, both planned and unplanned. Suggestions of possible things to include were made, such as:

- Block Captains should turn on their radios immediately to await information.
- When performing Block Captain duties, Block Captains should wear their MVEST vest and helmet, keep their radios with them, and carry a flashlight.
- MVEST volunteers should place power strips in the clubhouse for residents to charge phones and electrical equipment.
- MVEST volunteers should place a whiteboard sign at the clubhouse with current information, even the fact that there is no information except "it's being worked on and we will let you know when we know more."
- There should be a backup person to Matt who can activate robocalls.
