#### **MVEST Notices and Project Reports**

#### Coronavirus

Though the mask mandate for indoor spaces has been lifted for Marin County, many people will continue the practice, as there are new variants that are even more transmissible than earlier ones. Residents are reminded to get tested if they suspect they have been exposed, even if they have no symptoms, and also that a second booster vaccination shot is available for people over 50 years old. One major area of concern is "long Covid," which affects more than one third of the people who contract the disease, even if they are asymptomatic until after the supposed duration of the infection. Marin County currently is experiencing an uptick in the number of cases and hospitalizations.

#### Park Safety/Security

Residents are reminded that if they see an actual crime in progress, they should immediately call 9-1-1; otherwise, all suspicious persons or circumstances should be immediately reported to Matt Greenberg, Park General Manager, by calling 415-883-5911, day or night, and Matt will take appropriate action. If residents can take photographs of suspicious vehicles or individuals without their knowledge, that is helpful, but residents should usually avoid confronting suspicious persons as this can prove dangerous.

#### Fire Safe Marin

John H. reported again that the next meeting of the Fire Safe Marin Board of Directors will be Wednesday, June 22 at 9:00 a.m. and can be accessed through the Fire Safe Marin website.

John H. reported that the Ember Stomp event of May 28 at the Marin Civic Center was very successful. Several committee members attended, as well as other Marin Valley residents, and John H. volunteered at the event.

John H. reported that the report from FSM's Mobile Home Wildfire Safety Committee is now posted on FSM's website as well as on <u>marinvalley.net</u>. There is also a brochure that is being sent to the managers of all the mobile home parks in Marin, enough for all residents.

## Marin Valley Firewise

John H. reported that he has not yet received news about the outcome of the proposal he submitted for a \$10,000 PG&E grant for the maintenance of defensible space, specifically for the area near 199 Marin Valley Drive.

John H. reported that he will attend the next HOL meeting and ask about collaborating with them regarding defensible space (D-space) work in residential spaces in the Park.

Ellen Jane again expressed concern about the fire danger of the acacia trees abutting her space. John H. will talk to Matt about this.

John H. reported that it would cost \$600 to buy fire extinguishers for trainings of residents. If Matt okays the purchase, John H. will do so.
